Bechtel #2917, who after being by me duly sworn, on oath deposes and says that she has good reason to believe and does believe that heretofore to wit: on or about the 3rd of January 2023 and before the filing of this complaint in the County of El Paso, the State of Texas, one Saucedo Gabriel (0911/1979), Hereinafter called the DEFENDANT, did then and there knowingly possesses, accesses with intent to view, or promotes visual material that: (1) depicts the lewd exhibition of the genitals or pubic area of an unclothed, partially clothed, or clothed child who is younger than 18 years of age at the time the visual material was created, to wit: defendant was in care, custody and control of the listed email address: gsaucedo4@gmail.com.

## PC:

The affiant, Detective C. Bechtel #2917 who is currently assigned to Internet Crimes Against Children was assigned Cyber Tip Number: 114430535 from the National Center for Missing and Exploited Children (NCMEC) and is attached to NCMEC Cyber Tips: 110391434, 110280495, 110623307, 114431143, 110318169 and 110305988. Information provided by the Cyber Tip indicated the defendant utilized Google to upload 74 images of lewd visual material depicting a child between the dates of 12/10/2021 - 01/04/2022. Cyber Tip # 114430535 provided the following suspect identifiers: defendant's name, defendant's date of birth (09/11/1979), mobile phone number: (915) 731-3695 and email address of gsaucedo4@gmail.com.

The affiant reviewed the files attached to Cyber Tip #114430535 and observed 74 photographs of lewd visual material depicting a child.

## Filenames:

Google-CT-RPT-5a35d639327d6012b1aa56c2afd93a19-sand (34) is a photograph that depicts a prepubescent remaile child, approximately 7-8 years of age laying on a bed, wearing white lace stockings and red lingerie with her legs behind her ears and her anus exposed.

Google-CT-RPT-994769e780a3a98b5fc6703d1e177d60-IMG\_2459 is a photograph that depicts a prepubescent female child, approximately 8-10 years of age who is nude and sitting on her buttocks and leaning back onto her hands with her vagina exposed.

Google-CT-RPT-4916937d7115748904faad0987fdd162-IMG\_2408 is a photograph that depicts a prepubescent female child, approximately 8-10 years of age seated with her legs crossed and her vagina exposed while she holds a black sex toy in her right hand.

Google-CT-RPT-4598e473d4bf5e3c324bba551229d651-sand (13) is a photograph that depicts a female child, approximately 10-12 years of age seated on a bed, wearing black fishnet stocking, silver platform high heels and a white t-shirt with her legs spread open and her vagina exposed.

Affiant obtained a search warrant 2022SW00345 for the suspected Google account: gsaucedo4@gmail.com for the seizure and examination of the contents of the suspected account. Affiant received the search warrant return on 01/03/2023. Upon review of the of the search warrant return, Affiant located subscriber information which indicted email address gsaucedo4@gmail.com is subscribed to the defendant, with phone number (915) 731-3695 is registered to the defendant. Affiant received records from T-Mobile, which indicated the listed phone number belongs to the defendant. Also located in the warrant return, were files previously flagged and reported by Google to NCMEC.

On 01/23/2023 at approximately 1518 hours, Affiant called the defendant at the listed phone number and the defendant confirmed his identity by providing his date of birth and confirming he is the individual who owns the listed phone number. Defendant also provided a secondary email address of <a href="mailto:avamateo@hotmail.com">avamateo@hotmail.com</a> which was listed in Cyber Tip #11440535. Affiant conducted a records check and was able to verify that the defendant utilized email address <a href="mailto:gsaucedo4@gmail.com">gsaucedo4@gmail.com</a> to apply for his Texas Driver's license.
